Thirteenth Sunday in Ordinary Time

Beloved in the Lord,

This is an historic moment.

The United States Supreme Court's decision on the Dobbs v. Jackson case has overturned the Roe v. Wade decision of 1973, now interpreting that the United States Constitution does not restrict states from making regulations restricting or prohibiting abortions.

This decision does not conclude the matter. It has become an issue for each state to address. Some states have already addressed it in anticipation of this ruling.

We can make it a hopeful moment.

Polarization due to this issue will continue. Polemics will echo in the public square. However, let us keep things in perspective.

This is a human rights issue. A human being has an inherent dignity from the moment of her or his conception. This inherent dignity is not changed by the stage of development. It is not changed by the condition or circumstance that a human being is experiencing. This is a hopeful message.

This principle is grounded in faith and reason. We are not imposing our faith upon others. Reason alone can tell us that a human being has been conceived. Dehumanizing creates a verbal deception that can lead to destructive consequences.

Before I continue, if you have had an abortion or assisted in this tragic action, there is hope for healing. I know from pastoral experience that women and men have benefited from the Project Rachel ministry.
